



## BUCK POND FARM BREEDING SHED REQUIREMENTS- 2009

**\*\*BUCK POND WILL NOT REQUIRE A BREEDING SHED FORM FOR 2009\*\***

Signed contract or Shareholder authorization and **COMPLETED** mare information sheet **MUST** be on file in office prior to Breeding.

**ALL** mares presented for breeding **MUST** be vaccinated for the Equine herpes Virus Type 1 (ie: Rhinomune, Pneumabort K, etc) between 7-90 days prior to breeding. All mares shipping in directly from any racetrack or that have not been boarded in Kentucky (not including racetracks) for a period longer than 45 days must provide a veterinary statement for proof of vaccination.

**ANY** mare presented for breeding without the proper identification (halter id/neck strap id) **WILL NOT BE BRED.**

**BARREN AND NOT BRED MARES:** All barren mares and those not bred in 2008 are required to have a clean culture taken in 2009. A clean culture certificate must accompany the mare to the breeding shed. A clean culture will be required for **3rd** and subsequent return covers (Not including doubles). The first three (3) mares bred after an imported mare must be CF tested 15 - 40 days post breeding, see imported Foaling and Barren Mares below.

**MAIDEN MARES:** **ALL** maiden mares **must be jumped** before coming to the breeding shed. The clean culture requirements are the same as stated above for barren and not bred mares. The first three (3) mares bred after an imported mare must be CF tested 15-40 days post breeding, see imported Foaling and Barren Mares.

**FOALING MARES:** No culture is required for the first cover. A clean culture is required for ALL return covers (not including doubles). Culture must be taken from the current heat cycle. The first three (3) mares bred after an imported mare must be CF tested 15-40 days post breeding, see imported Foaling and Barren Mares.

**IMPORTED MAIDEN MARES:** In addition to the normal requirements for maiden mares, all fillies of foreign origin (except Canada) which have not been qualified for cover during the previous breeding season are required to have two (2) sets of negative CEM cultures. One set of cultures must be obtained in early estrous; the second may be obtained during a period of 7 to 14 days before or after the culture in estrous. The first three (3) mares bred after an imported mare must be CF tested 15-40 days post breeding, see imported Foaling and Barren Mares.

**IMPORTED FOALING AND BARREN MARES:** Contact the state veterinarian's office in Frankfort KY (502) 564-3956 regarding testing procedures and acquisition of a quarantine release. A copy of the QUARANTINE RELEASE must accompany the mare on her first trip to the breeding shed. The first three (3) mares bred after an imported mare must be CF tested 15 - 40 days post breeding.

**EVA POSITIVE MARES:** Any mare which is EVA positive without proof of being sero-negative prior to vaccination must be identified as such when booking the mare and will be bred last in line on any given day

**\*\*\*Foal Heat and Doubles may be bumped on short notice for first- heat mares\*\*\***
